Article I: The name of the organization shall be the Maroon & White Gridiron Club.

Article II: Mission Statement

The Maroon & White Gridiron Club has been formed for the primary purpose of promoting a high degree of voluntary community participation, support, and sponsorship in the Pleasantville High School Football Program.

Article III: Membership

Section 3.1-Eligibility - must be over the age of 21. Any new member must fill out an application, be sponsored by at least three members in good standing, and then voted on. To become a member the applicant must be approved by a $\frac{2}{3}$ majority vote of the Executive Board, then approved by $\frac{2}{3}$ of the body in good standing. Membership Classes

Section 3.2-Active Member: Voting Rights: Must be a member in good standing. A member must attend 75% of all meeting and outside activities (fundraisers, etc.). Active membership may be terminated for misconduct or conduct detrimental to the good of the organization as deemed by the President or the Board of Directors.

Section 3.3-Associate Member: Shall have all the membership rights except voting rights. Associate members cannot hold office and do not have to attend meetings.

Section 3.4-Termination of Membership: A member may be suspended or terminated by the Board of Directors upon its finding that such member shall have violated the rules or policies of the Chapter, subject to such procedures as the Board of Directors shall deem appropriate to permit any such member to be advised of, and answer such charges as may be made against the member.

Section 3.5-Reinstatement: Upon written request signed by a suspended or terminated member and filed with the secretary, Board of Directors may, by the affirmative vote of % of the Active Members, reinstate such suspended or terminated member to membership upon such terms as the Board of Directors seem appropriate.

Section 3.6-Meetings: Regular meetings shall be held on the 3rd Thursday of each month.

Section 3.7-Special Meetings: Special meetings of the members may be called at any time by the Board of Directors or by written request of $\frac{1}{3}$ active members. Such request must be submitted to the secretary and it shall be the duty of the secretary to fix the time and date of the meeting.

Article IV:

Section 4.0-The office of the Maroon and White Gridiron Club shall consist of President, Vice-President, Secretary and Treasurer.

Section 4.1-Nominations: Candidates to fill each office position shall be made by a nominating committee of no less than three (3) members in good standing as appointed by the president. Also, any member in good standing may nominate a candidate for office with a second. All office positions are a 2-year term.

Section 4.2-Election: All officers shall be elected by written ballot by all active members in good standing. The election shall take place during the January meeting.

Section 4.3-Exceptions: No active Pleasantville High School football coach may hold office. Any new member must be an active member for at least one (1) full year. No Associate members may hold office. Section 4.4-Vacancies: Vacancies occurring in any office shall be filled by appointment by the President upon approval of The Board of Directors. The Term shall be for the duration of the unexpired term of the office vacated. If the President's office is vacated, then the Vice-President will become the President and shall appoint a Vice-President per Section 4.4.

Article V:

Section 5.0-Board of Directors: The Board of Directors shall be composed of five (5) active members in good standing, for a two-year term. The President, Vice-President, Secretary and Treasurer along with all active members shall elect the Board of Directors. One of the members of the Board of Directors shall also be the Sergeant of Arms. Two (2) members shall be elected each year and the Sergeant of Arms/Board of Directors shall also be a two-year term.

Section 5.1-Exceptions: No active Pleasantville High School coach may be on The Board of Directors. Any new member must be an active member for at least one (1) full year. No Associate member may hold office of The Board of Director.

Section 5.2-Vacancies: Vacancies occurring in any Director position before the completion of the term of office shall be filled by appointment by the President upon approval of the Board. The Term shall be for the duration of the unexpired.

Section 5.3-Nominations: Shall be the same as in Section 4.1.

Section 5.4-Elections: Shall be the same as in Section 4.2.

Article VI: Team Liaison/Member Emeritus

Section 6.1- The current Head Football Coach at Pleasantville High School shall be the Liaison between the football program and the Maroon and White Gridiron Club. The goal of the Maroon and White Gridiron Club is to help the football program succeed any way it can, so if possible the requests of the Team Liaison should be met.

Article VII:

Sections 7.1 Duties of the officers:

- 7.1.1-President: The President shall be the chief executive officer. The President shall have general charge, supervision and control of the business affair of the organization under the direction of the Board of Directors. The President shall have the authority to fill all vacancies on the Board of Directors or the Officers pursuant to sections 4.4 and 5.2. The President shall preside at all meetings of the members and at all meetings of the Board of Directors.
- 7.1.2-Vice-President: The Vice-President shall preside over meetings in the absence of the President. The Vice-President shall assume the President's position if the President vacates his position for any reason. The Vice-President shall perform any other duties as directed by the President.
- 7.1.3-Secretary: The Secretary shall keep all records pertaining to the organization, shall record and keep minutes of all meetings and be prepared to read such minutes at each scheduled meetings. The Secretary shall prepare an organization roster of informational names, addresses, e-mail addresses and phone numbers. Shall handle all correspondence, including the mailing of notices of meeting and set any special meetings, times and dates.
- 7.1.4-Treasurer: The Treasurer shall have care and custody of and be responsible for all funds of the organization. The Treasurer shall deposit all such funds in depository directed by the officers and Board of Directors. These funds will be deposited under the organization name. All checks will bear two (2) signatures. One of the Treasurer and the other one may be the President or Vice-President. The Treasurer shall render a monthly, written, detailed statement of the finances to be read at each regular meeting. He or she shall submit a full financial report at the annual meeting. Any check exceeding \$500.00 must have the Board of Directors prior approval. A complete independent audit of the financial records shall be made at the end of each fiscal year and made available upon request. At no time shall the treasurer intermingle the organizations funds with personal funds.

Article VIII: Duties of the Board of Directors

Section 8.1-The Board of Directors shall: approve the annual budget and be empowered to investigate and rule on the following:

A-Infractions of these By-Laws.

B-Conduct of the organization, its officers, members and all who participate in the organization.

C-Such other matters that may be considered as detrimental to the good of the organization.

Article IX: Voting

Section 9.1: A majority vote by a quorum will be required to pass all motions and prevail in all matters unless otherwise specified in these By-Laws. A minimum of fifteen (15) members in good standing constitutes a quorum. Officers and Board of Directors included.

Section 9.2: At least $\frac{2}{3}$ Vote of the Executive Board in good standing to vote in By-Law changes. A minimum of six (6) members in good standing constitutes a quorum.

Section 9.3: There will be NO voting by proxy.

Article X: By-Law Amendments

Section 10.1: Procedure

- **A.** All proposed amendments to these By-Laws shall be given in writing to the Board of Directors at least two weeks prior to the regular meeting in March. It shall be the function of the Board to clarify and explain that the language of the statement is in the proper form. The Board will not change the intent of the proposal.
- **B.** A proposed By-Law amendment must be read at two consecutive regular organization meetings. (March and April)
- **C.** Section 10.2: Ratification
