AVID is part of the Middle's School SIP. The term of the agreement is from July 1, 2014 through June 30, 2015. AVID includes a Summer Institute component that will focus on leadership systems, instruction and culture. The total cost to implement the AVID program for 2014-2015 school year is not to exceed \$22,357.00.
