WHEREAS, The Board of Education of the City of Pleasantville in the County of Atlantic, New Jersey (the "Board") has determined that it is necessary to replace the heating, ventilation, and air conditioning systems, including all incidental work, at the South Main Street Elementary School, located at 701 South Main Street, Pleasantville, New Jersey (the "Project") through a lease purchase transaction; and

WHEREAS, the Board has determined to pursue the lease purchase financing method, in accordance with N.J.S.A. 18A:20-4.2(f) and its regulations at N.J.A.C. 6A:26-10.1 <u>et seq.</u>, to finance the Project; and

WHEREAS, the Board held a public hearing with respect to the proposed method of financing for the Project on January 28, 2014 after duly publishing a notice in accordance with the requirements of the regulations; and

WHEREAS, the Board has selected McManimon, Scotland & Baumann, LLC to serve as Special Counsel (the "Special Counsel") for the transaction contemplated herein; and

WHEREAS, the Board hereby ratifies the publication of the notices of public hearing and request for the receipt of proposals for the selection of a lessor and investor, if necessary, to enter into a lease purchase agreement for the Project; and

WHEREAS, the Board authorizes the Business Administrator/Board Secretary to either solicit proposals for the selection of a lessor and investor or to select a lessor and investor through a negotiation in accordance with N.J.S.A. 18A:20-4.2(f); and

WHEREAS, the Board wants to delegate to the Business Administrator/Board Secretary the ability to award the lease; and

WHEREAS, the Board and the prospective financing company now intend to enter into a lease purchase agreement, a ground lease agreement and all such other agreements and documents as may be necessary to complete the transaction once the Board receives the required approval of the Commissioner of Education (collectively, the "Lease"); and

WHEREAS, the Board now wants to delegate to the President and the School Business Administrator/Board Secretary the ability to execute the Lease and other related agreements and financing documents with the prospective purchaser of the lease purchase agreement (referred to herein as the "Lessor" and "Purchaser") upon the terms and the conditions set forth in this resolution;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE CITY OF PLEASANTVILLE IN THE COUNTY OF ATLANTIC, NEW JERSEY AS FOLLOWS:

Section 1. The Board hereby endorses the concept of the lease purchase financing of the proposed Project.

Section 2. The Board hereby determines that the annual rent payments, consisting of principal portion and an interest portion, to finance the Project can be included within its net budget spending growth limitation and that such payments will not result in the need for approval by the voters of additional spending proposals to maintain existing instructional programs or extracurricular activities.

Section 3. The Business Administrator/Board Secretary, together with the Superintendent of Schools, Bond Counsel, the Board Attorney and other appropriate representatives of the Board (together, the "School District Professionals") are hereby authorized to either advertise and to solicit proposals for the selection of a lessor and investor, or to select and to negotiate a proposed interest rate with a lessor, and to take other appropriate steps necessary to prepare for the proposed lease purchase financing of the

Project, and all such actions taken to date are hereby ratified. The Business Administrator/Board Secretary is hereby authorized to award the Lease as indicated herein.

Section 4. The Business Administrator/Board Secretary, together with the other School District Professionals, are hereby authorized to make application on behalf of the Board to the Commissioner of Education for the approval of the proposed lease purchase agreement for the Project and related documents in accordance with the requirements of the regulations.

Section 5. The Board hereby approves the total project cost of \$1,700,000 resulting in a lease purchase agreement in the principal amount not to exceed \$1,700,000 to finance the Project.

Section 6. The Board hereby authorizes the execution and the delivery of and the performance by the Board of its obligations under the Lease, which shall be substantially in the form on file with the School Business Administrator/Board Secretary, in accordance with the provisions of this resolution.

The Board hereby authorizes and directs the Board President or the School Business Administrator/Board Secretary to approve any changes, additions or deletions to the Lease as may, in the judgment of Special Counsel, be necessary or advisable, such approval to be evidenced by the execution of the Lease by the Board President or the School Business Administrator/Board Secretary.

Section 7. The Board hereby authorizes the execution and the delivery of and the performance by the Board of its obligations under the Ground Lease Agreement, which shall be substantially in the form on file with the School Business Administrator/Board Secretary, in accordance with the provisions of this resolution. The Board hereby authorizes and directs the Board President or the School Business Administrator/Board Secretary to approve any changes, additions or deletions to the Ground Lease Agreement as may, in the judgment of Special Counsel, be necessary or advisable, such approval to be evidenced by the execution of the Ground Lease Agreement by the Board President or the School Business Administrator/Board Secretary.

Section 8. The Board hereby authorizes the Business Administrator/Board Secretary, if necessary, to enter into an escrow deposit agreement (the "Escrow Deposit Agreement") for a fee to be negotiated, which shall be substantially in the form on file with the School Business Administrator/Board Secretary, in accordance with the provisions of this resolution and to pay any associated costs. The Board hereby authorizes and directs the Board President or the School Business Administrator/Board Secretary to approve any changes, additions or deletions to the Escrow Deposit Agreement as may, in the judgment of Special Counsel, be necessary or advisable, such approval to be evidenced by the execution of the Escrow Deposit Agreement by the Board President or the School Business Administrator/Board Secretary.

Section 9. The payments of rent or other monies due under the Lease shall be made only from the General Fund of the Board. Neither the Board, any agency, department or political subdivision thereof shall be obligated to pay any sum to the Lessor under the Lease from any taxing source for the payment of any sums due under the Lease. The obligations of the Board under the Lease shall not constitute indebtedness of the City of Pleasantville or of any department, agency or political subdivision

thereof. The Lease sets forth the term of the Lease, the rental payments to be paid by the Board in respect thereof and the dates on which rents shall be due and payable.

- Section 10. The proceeds of the sale of the Lease shall be applied to (i) pay costs of the Project, (ii) pay accrued interest on the Lease, if any, and (iii) pay the costs of entering into the Lease.
- Section 11. The Board hereby authorizes the preparation, the execution and the delivery of and the performance by the Board or its representatives of its obligations under the Lease, the Ground Lease, the Escrow Agreement and other related agreements and documents.
- Section 12. The Board President or the School Business Administrator/Board Secretary are hereby authorized and directed to execute and to deliver on behalf of the Board the agreements referred to herein, if needed, and any such other agreements as may be necessary to carry out the transaction authorized by this resolution. The Board President, the School Business Administrator/Board Secretary, the School District Professionals and other appropriate representatives of the Board are hereby authorized and directed to take on behalf of the Board such other actions as shall be necessary and appropriate to accomplish the transaction contemplated by this resolution and the agreements authorized herein.
- Section 13. The Board hereby covenants that it will comply with any conditions subsequent imposed by the Internal Revenue Code of 1986, as amended (the "Code"), in order to preserve the exemption from taxation of the interest portion of the rental payments under the Lease, including the requirement to rebate all net investment earnings on the gross proceeds above the yield on the Lease. The Lease will be designated as a "qualified tax-exempt obligation" for the purposes of Section 265(b)(3)(B)(ii) of the Code.
- Section 14. If necessary, the Board reasonably expects to reimburse its expenditure of Project costs paid prior to the issuance of the Lease with proceeds from the tax-exempt lease.
 - (A) This resolution is intended to be and hereby is a declaration of the Board's official intent to reimburse the expenditure of Project costs paid prior to the issuance of the Lease with the proceeds of the Lease, in accordance with Treasury Regulations §150-2.
- (B) The Project costs to be reimbursed with the proceeds of the Lease will be "capital expenditures" in accordance with the meaning of Section 150 of the Code.
- (C) No reimbursement allocation will employ an "abusive arbitrage device" under Treasury Regulations §1.148-10 to avoid the arbitrage restrictions or to avoid the restrictions under Sections 142 through 147, inclusive, of the Code. The proceeds of the Lease used to reimburse the Board for Project costs will not be used in a manner that results in the creation of "replacement proceeds," including "sinking funds," "pledged funds," or funds subject to a "negative pledge" (as such terms are defined in Treasury Regulations §1.148-1), of the Lease, other than amounts deposited into a "bona fide debt service fund" (as defined in Treasury Regulations §1.148-1).

(D) All reimbursement allocations will occur not later than 18 months after the later of (i) the date the expenditure from a source other than the Lease is paid, or (ii) the date the Project is "placed in service" (within the meaning of Treasury Regulations §1.150-2) or abandoned, but in no event more than 3 years after the expenditure is paid.

Section 15. This resolution shall take effect immediately.

26. **Resolution to approve** the Settlement and Agreement and General Release (hereinafter referred to as the "Settlement Agreement") is made effective as of the 1st day September, 2013 by and between the Petitioner Antoinette Wilson (hereinafter referred to as the "Petitioner") and the Respondents Pleasantville Board of Education (hereinafter referred to as the "Board") (collectively the "parties").

WHEREAS, the Board is a body corporate and politic of the State of New Jersey; charged with the statutory responsibilities for the management and administration of Pleasantville School District in Atlantic County, New Jersey; and

WHEREAS, the Petitioner was hired by the Board as a Supervisor of Guidance assigned to the guidance department; and

WHEREAS, on December 11, 2012, Superintendent recommended that all Supervisor positions be eliminated; and

WHEREAS, the Board rejected the Superintendent's recommendation and did not act to abolish the positions; and

WHEREAS, on December 14, 2012, the State Monitor overturned the Board's decision, in accordance with N.J.S.A. 18A:7 A-55, and approved abolishing all Supervisory positions; and

WHEREAS, Petitioner was terminated on December 18, 2012; and

WHEREAS, Petitioner filed a claim with the Commissioner of Education asserting that the Board violated her tenure and seniority rights by failing to offer her a guidance counselor position; and

WHEREAS, the Board filed an Answer and later an Amended Answer denying it violated Petitioner's tenure seniority rights; and

WHEREAS, the parties wish to settle all controversies among and between them, and any and all related or unrelated claims, known or unknown, which could have been asserted by the Board or Petitioner through this Settlement Agreement; and

WHEREAS, the parties acknowledge that the merits of the controversy are in dispute and that neither the Board nor the Petitioner admits any liability to either, but both have reasons to desire a resolution of the matter; and

NOW THEREFORE, in consideration of the agreements, promises, covenants and conditions contained herein, the adequacy and sufficiency of which are expressly acknowledged by the parties hereto and the recitations set forth above which are incorporated by reference herein, the parties agree as follows:

1. REINSTATEMENT AND SALARY.

- (a) The Board will reinstate Petitioner as a non-tenured guidance counselor at the Middle School and will pay Petitioner a salary retroactively from September 1, 2013 to the present. Petitioner will not receive any additional retroactive pay for the period of her separation from the Pleasantville School District.
- (b) Petitioner will be required to perform the duties and responsibilities of a guidance counselor as described in the job description attached hereto as Exhibit A.
- (c) Petitioner's annual salary shall be \$86,518.00 which represents Doctorate level, step 16 on the relevant salary guide, subject to negotiations between the Board and the Pleasantville Education Association for the 2013-2014 school year. Petitioner's accrued sick days shall be restored to her and any sick days for the current 2013-2014 school year will be prorated. Petitioner will be subject to the provisions of TEACH NJ and will achieve tenure in accordance with the provisions of N.J.S.A. 18A:28-5.Tenure and seniority acquired previously in the district under separate certifications is preserved.
- (d) The retroactive salary will be paid in a lump sum in the amount of \$37,079.14 payable to Petitioner within thirty (30) days after receipt by Respondent's' counsel of the original signed Settlement Agreement and Release. Petitioner understands and unequivocally and irrevocably agrees that the retroactive amount is subject to the customary and usual deductions, including but not limited to her pension contribution to the Division of Pensions.
 - DISMISSAL OF ACTION. Upon final execution of this Settlement Agreement, Petitioner and/or her counsel shall
 cause to be filed with the Office Administrative Law any and all required documents to withdraw and/or dismiss the
 claims asserted in her Petition filed with the Commissioner of Education docketed as No. EDU-06386-2013S with
 prejudice and without costs. A copy of said filing will be forwarded to Respondent.
 - 3. <u>RELEASE</u>. Petitioner, personally and for her legal or personal representatives, assignee, estate and/or heirs, waives, releases and gives up any and all other claims, demands, obligations, damages, liabilities, causes of action and rights, in law or in equity, known and unknown, that she may have against the Board and any and all of its officers, directors, agents, representatives and employees (present and former) and their respective successors and assigns, heirs, executors and legal or personal representatives, based upon any act, event or omission occurring before the execution of this Settlement Agreement including, but not limited to, any events related to, arising from or in connection with Petitioner's employment with the Board or related to the claims asserted in <u>Wilson v. Pleasantville Board Education et.al.</u>, Docket No.: EDU-06386-2013S. Petitioner specifically waives, releases and gives up any and all claims arising from or relating to her employment and/or association with the Board based upon any act, event or omission occurring before the execution of this Settlement Agreement including, but not limited to, any claim that was asserted or could have been asserted under any federal or state statutes, regulations, or common law or Board policies or regulations. Respondent specifically agrees that petitioner is not waiving her tenure, seniority and

recall rights as a supervisor in the event that said position, is recreated in the future. Petitioner understands and agrees that she would not otherwise be entitled to the consideration provided to her as set forth in paragraph no. 1 above and her Release of Respondent includes but is not limited to, any claims which have been asserted or could have been asserted now for defamation and under any Federal, State of Local Laws or Ordinances as amended, including but not limited to any claims under Title VII of the Civil Rights Act of 1964, the Civil Rights Act of 1991, 42 U.S.C. section 2000(e) et seq. ("Title VII"), 42 U.S.C. section 1981,42 U.S.C. section 1983, The Americans with Disabilities Act,42 U.S.C, section 12,101 et seq. ("ADA"), the Age Discrimination in Employment Act, 29 U.S.C. section 621 et seq. ("ADEA"), all applicable New Jersey statutes governing discrimination in employment, overtime compensation and any other laws or ordinances, the Conscientious Employee Protection Act, N.J.S.A.34:19-1 et seq. ("CEPA"), the New Jersey Law Against Discrimination, N.J.S.A. 10:5-1 et seq. ("NJLAD"), the Employee Retirement Income Security Act of 1974, 29 U.S.C. section 1001 et seq. ("ERISA"), the Fair Labor Standards Act, 29 U.S.C. section 201et seq. ("FLSA"), The Equal Pay Act, 29 U.S.C. section 206(d)(1)("EPA"), The Family and Medical Leave Act, 29 U.S.C. section 2601 et seq. Petitioner hereby waives and releases any right to file a complaint for any actions related to any tort claim notices that she has previously filed against the Board and any employee.
- 5. <u>ATTORNEY FEES.</u> Each party agrees that each party will bear its own costs and attorney's fees which have been incurred in connection with the within matter and in conjunction with the negotiation and preparation of this Settlement Agreement.
- 6. <u>NO ADMISSION OF LIABILITY.</u> It is expressly understood that neither the execution of this Settlement Agreement, nor any other action taken by the Petitioner in conjunction with the Board's claims or this Settlement, constitute admission by the Petitioner of any violation of any law, duty or obligation. It is also understood that the acceptance of this Settlement does not constitute any representation by the Board as to the merits of its claims or the lack thereof.
- 7. ENTIRE AGREEMENT. This Settlement Agreement contains the sole and entire agreement between the parties hereto. Each party represents and acknowledges that prior to executing this Settlement Agreement, they consulted with or had an opportunity to consult with counsel, has had ample time to do so and that no party relied upon any representation or statement not set forth in this Settlement Agreement made by any other party hereto, or their counsel or representatives, with regard to the subject matter of this Settlement Agreement.
