FINANCE ADDENDUM NO. 1C

**Resolution to approve** the Settlement and Agreement and General Release between Constance Evans (collectively referred to as "Evans" or "plaintiff") and the Pleasantville Board of Education (collectively referred to as "Defendant") effective June 19, 2014.

**GENERAL RELEASE**

1. For good and valuable consideration in the amount of Three Hundred Fifty Thousand Dollars (\$350,000.00) (the "settlement sum"), and other sufficient consideration stated below, and intending to be legally bound hereby, **CONSTANCE EVANS**, her agents, attorneys, personal representatives, beneficiaries, heirs, successors and assigns (collectively referred to as "Evans" or "plaintiff"), hereby releases and forever discharges the **PLEASANTVILLE BOARD OF EDUCATION**, its past, current and future board of education members, officers, directors, trustees, board of trustees/directors, shareholders, partners, members, administrators, employees, agents, attorneys, personal representatives, insurance carriers, parent, affiliated and/or subsidiary companies, predecessors, successors and assigns (collectively referred to as "Defendant") from any and all claims, demands, damages, sums of money, costs, expenses, attorneys' fees, actions, rights, causes of action, agreements, promises, obligations or liabilities of any kind whatsoever, whether known or unknown, fixed or contingent, suspected or unsuspected, which Evans ever had, now has or hereafter can, shall or may have against any of them for or upon any matter, cause or thing whatsoever from the beginning of the world to the day and date of this Release, including, but not limited to each claim or matter which was asserted or which could have been asserted by Evans relating to her employment with the defendant, the grievance she filed pursuant to the Collective Bargaining Agreement, and all claims/causes of action which were asserted or which could have been asserted by Evans in her lawsuit filed in the Superior Court of New Jersey, Docketed as No. L-779-13 and/or for any other reason whatsoever (hereinafter the "claims").

2. The settlement sum will be paid as follows: \$350,000.00 to "Richard Pescatore on behalf of Constance Evans" within 45 days of receipt of an executed version of this Release. Except as otherwise provided herein, Evans agrees to be solely responsible for and legally bound to make payment of the taxes which any taxing authority determines are owed by Evans on the payments noted above. In the event that any claim is made against Evans for taxes, penalties and/or interest due with respect to the payments noted above, except as otherwise provided within this Agreement, Evans agrees to indemnify and hold defendant harmless against any liability for such taxes, penalties and/or interest which may be due as a result of Evans

failure to pay appropriate taxes on such payments. Nothing herein shall be construed to render Evans responsible for any employment taxes, insurance or related payments subsequently determined to be the sole responsibility of the defendant.

Plaintiff and/or her counsel shall cause to be filed with the Court any and all required documents to withdraw and/or dismiss the claims with prejudice and without costs. Evans understands and agrees that she would not otherwise be entitled to the consideration provided to her as set forth in paragraph no. 1 above and that her Release of defendant includes, but is not limited to, any claims which have been asserted or could have been asserted now under any Federal, State or Local Laws or Ordinances as amended, including, but not limited to, any claims under Title VII of the Civil Rights Act of 1964, The Civil Rights Act of 1991, 42 U.S.C. §20001 *et seq.* ("Title VII"), 42 U.S.C. §1981, 42 U.S.C. §1983, The Americans with Disabilities Act, 42 U.S.C. §12,101 *et seq.* ("ADA"), The Age Discrimination in Employment Act, 29 U.S.C. §621 *et seq.* ("ADEA"), all applicable New Jersey Statutes governing discrimination in employment, defamation, overtime compensation, the Conscientious Employee Protection Act, N.J.S.A. 34:19-1 *et seq.* ("CEPA"), the New Jersey Law Against Discrimination, N.J.S.A. 10:5-1 *et seq.* ("NJLAD"), The New Jersey Civil Rights Act, N.J.S.A. 10:6-2 *et seq.* ("NJCRA"), the New Jersey Family Medical Leave Act, N.J.S.A. 34:11B-1, *et seq.* ("NJFMLA"), The Employee Retirement Income Security Act of 1974, 29 U.S.C. § 1001 *et seq.* ("ERISA"), The Fair Labor Standards Act, 29 U.S.C. § 201 *et seq.* ("FLSA"), The Equal Pay Act, 29 U.S.C. § 206(d)(1) ("EPA"), The Family and Medical Leave Act, ("FMLA") any and all Employee/Whistleblower Protection Acts, any applicable Local Ordinance, any contracts between Evans and the defendant and any other law or right created by statutes, regulation or common law now or hereafter recognized, of any nature whatsoever, and all claims for counsel fees and costs. Evans understands that by signing this Release, she foregoes any and all rights to sue defendant and/or to pursue appeals from any adverse judgment for any cause or liability arising on or before the date of this Release for race, gender, age, national origin, disability and/or religious discrimination, hostile work environment, sexual harassment, sexual orientation, gender stereotyping any claims under applicable New Jersey laws or ordinances, Title VII, ADA, ERISA, FLSA, EPA, CEPA, NJLAD, NJCRA, NJFMLA, FMLA, whistle blower and/or employee protection statutes, retaliation, contract, tort, defamation, invasion of privacy, negligence and for any other reason whatsoever. Evans covenants that, as of the date of her execution of this Release/Agreement, other than any injury which she has already disclosed, she does not suffer from any injury or illness related to her employment with defendant, including any injury compensable under the Workers Compensation Act and that her earning capacity is not impaired by any work-related injury or illness. However, notwithstanding the provisions of this paragraph, it is understood and agreed that Evans is not waiving ordinary claims for accrued and vested benefits under any applicable qualified plan(s), and challenges to the validity of this Waiver and Release under the Older Workers' Benefit Protection Act.

3. Evans hereby acknowledges that she has been advised in writing to seek the advice of counsel prior to signing this Release and that she has obtained the advice of competent, private counsel to advise her in the negotiation and consummation of this Settlement of the claims; or she has knowingly and voluntarily chosen not to seek such advice. Evans also acknowledges that she has been given a reasonable period of time to review this Release and that she has taken all of the time she needs or wants to review the Release. Accordingly, Plaintiff agrees that she has entered into this Release and Settlement of the claims knowingly and voluntarily.

4. Except for the inclusion of same in the amount referenced in paragraphs 1 and 2 above, Evans and defendant shall pay their own expenses, including, without limitation, court costs, legal and expert fees, incurred in the prosecution and defense of the claims and incurred in the negotiation, preparation and execution of the Release. Evans specifically acknowledges that she is not entitled to an award of attorneys' fees as a prevailing plaintiff under CEPA.

5. In addition to specifically and unconditionally releasing defendant from any and all claims which arose up to and including the date of this Release, Evans further acknowledges with respect to her release of claims under the Age Discrimination in Employment Act, as amended, and the Older Workers Benefit Protection Act, as amended, (collectively "ADEA") that:

(a) I have waived my claims knowingly and voluntarily in exchange for the consideration, compensation and benefits provided in accordance with this Release, and that I would not otherwise have been entitled to such consideration, compensation and benefits.

(b) I am advised by this Section 5(b) by defendant to consult with an attorney in connection with this Release and before signing the Release and I have consulted with my attorney of choice or have knowingly and voluntarily chose not to.

(c) I have been given a period of a full twenty-one (21) days to review and consider signing the original version of this Release. I understand and acknowledge that I am not required to use that full 21-day period before signing this Release, and that if I elect to sign the Release in less than that time, I do so voluntarily in order to obtain the benefits of the Release sooner.

(d) I understand that I may revoke my waiver of claims under the ADEA for a period of seven (7) days following the date I sign this Release and that my waiver of ADEA claims will not become effective until the seven-day revocation period has expired.

(e) If I revoke my waiver of ADEA claims in accordance with Section 5(d) above, I will not be entitled to any of the compensation or consideration detailed herein in accordance with the Release.

(f) I acknowledge and understand that defendant agrees that the Release provided by me does not include a release for claims under the ADEA for employment matters arising after the date I sign the Release.

(g) I acknowledge and agree that this Release complies in all respects with Section 7(f) of the ADEA, that is, the waiver provisions of the Older Workers Benefit Protection Act.

6. Evans affirmatively acknowledges and warrants that she has not filed any other complaint or claim against the defendant with any local, state or federal court regarding her employment with the defendant and that she will not do so in the future unless it is based on an alleged breach of this Agreement or for any conduct of defendants which may take place after the execution of this Agreement. Evans understands that nothing in this Release bars her from filing a charge or complaint of unlawful employment discrimination with an Agency, or assisting in an investigation of a charge or complaint of unlawful employment discrimination by an Agency. If any Agency or court has now assumed or later assumes jurisdiction of any complaint or charge on behalf of Evans against the defendant, Evans will disclaim entitlement to any relief for her personal benefit or the benefit of her heirs or assigns.

7. This Release will not become effective or be enforceable, and Evans will not be entitled to any compensation, consideration or benefits as detailed herein, until Evans has provided this signed Release to defendant's counsel, the seven-day revocation period has expired and Evans has not revoked this Release during the seven-day revocation period. To be effective, any such revocation must be in writing and delivered to Michele L. Weckerly, Esquire – Salmon, Ricchezza, Singer & Turchi LLP, 123 Egg Harbor Road, Suite 406, Sewell, New Jersey 08080; by the close of business on the seventh day after signing the Release, and such revocation must expressly state Evans's intention to revoke such Release. If Evans revokes this Release, she will not be entitled to any compensation, consideration or benefits detailed in this Release. If Evans does not timely revoke such Release, the eighth day following her signing of the Release shall be deemed the "Effective Date" of the Release.

8. It is agreed and understood that the merits, claims and any allegations of the parties and all other matters which have or might have existed as of the date of the filing of Evans's Complaint or have been asserted under any federal, state or local law, decision, ordinance, regulation or contract remain disputed, and the agreement to resolve or settle any disputes or the claim is made on the understanding that in entering a settlement no party concedes the merits of the other party's claims or defenses. Accordingly, the agreement to settle the claim constitutes a compromise and shall not be construed as or offered in any forum or proceeding as evidence of any admission of or acknowledgement of liability or fault of defendant. Further, it is specifically understood that Defendant denies any and all liability or violation of law in connection with any of the aforesaid claims or matters, or any other matters involving or implicating Evans.

9. This Release shall be governed by and construed in accordance with the laws of the State of New Jersey with the exception of its choice of law principles, and except as preempted by federal law. Should any provision of this Release be determined by any court to be illegal, invalid or unenforceable, the validity of the remaining parts, terms or provisions shall not be effected and the illegal, invalid or unenforceable part, term, or provision will be deemed not to be a part of this Release.

The language of all parts of this agreement shall in all cases be construed as a whole, according to its fair meaning, and not strictly for or against any of the parties hereto.

10. This Release may be signed in counterparts and each of which shall be considered an original for all purposes, and all of which taken together shall constitute one and the same written agreement.

**BE IT RESOLVED, THIS AGREEMENT CONTAINS A RELEASE OF ALL KNOWN AND UNKNOWN CLAIMS, INCLUDING THOSE UNDER THE EQUAL PAY ACT, WHISTLE BLOWER AND EMPLOYEE PROTECTION ACTS, THE FEDERAL AGE DISCRIMINATION IN EMPLOYMENT ACT, FEDERAL ANTI-DISCRIMINATION LAWS, THE FAIR LABOR STANDARDS ACT, THE FAMILY AND MEDICAL LEAVE ACT, STATE OVERTIME COMPENSATION LAWS, THE NEW JERSEY LAW AGAINST DISCRIMINATION, THE CONCENTIOUS EMPLOYEE PROTECTION ACT, THE NEW JERSEY CIVIL RIGHTS ACT, THE NEW JERSEY FAMILY MEDICAL LEAVE ACT AND OTHER FEDERAL, STATE AND LOCAL LAWS PROHIBITING DISCRIMINATION, HARASSMENT, DISCRIMINATION IN PAYMENT OR COMPENSATION OR DISCHARGE FROM EMPLOYMENT.**
