We had submitted a detailed description in the grant of how it will be used. The grant will be used for next school year; card access for elementary schools, safety wands, security cameras, etc.

- Mrs. Jenkins-Smith introduced Ms. Carmen Torres Parent Liaison at Washington Avenue School, for she was selected to represent our state of New Jersey to go to Florida on a scholarship to attend the National PTA Convention; she was selected as a delegate as emerging minority leaders. Mrs. Jenkins-Smith presented Ms. Torres with a certificate on behalf of the Pleasantville School District.
 - Mrs. Doris Graves thanked Mrs. Torres.
 - Mrs. Torres thanked the Board for the certificate, and announced that she will bring information of resources that are available to our Parent Resource Center.

Report of the State Monitor - Mr. James L. Riehman:

> Mr. Riehman paraphrased, gave a brief synopsis, of the following submission.

"The latest New Jersey Quality Single Accountability Continuum, better known as QSAC, has been reviewed by the staff and copies distributed to the Board. The District Performance Reviews (DPRs), in the areas of Finance, instruction and Governance for the last three years indicated the district needs to provide a corrective action plan to improve these areas. The district will have to score over 80 in each of the categories including Operations and Personnel for the next three years in order to be in total compliance. The Operations and Personnel areas scored well above the score of 80 with this recent review. The goal will be to score 100 in each of these categories.

The requirements for submitting an improvement plan have been met. Now the task will be to implement those improvements as soon as possible. I will be working with the Board and the staff to assist in this effort. In preliminary discussions with Dr. Bailey and with Mrs. Graves, we will be planning at least one workshop this summer to work on the Governance section. This will include a review of Board Bylaws and Policies, the DPR indicators that will need to be improved and the Improvement Plan which highlights the areas needing improvement. I will also give the Board periodic reports on the progress in these areas.

In Finance, I am working with Mr. Mulvihill and Mr. Thompkins to see that all grant funds are expended before the deadlines of June 30th and August 31st. We also will be looking at the current budget with the State Budget Analyst to assure that all accounts are properly coded. Budget transfers need to be scrutinized to be in compliance with State

Code. A review of District surplus is ongoing and recommendations for utilization of any excess surplus will be brought to the Finance Committee for consideration.

In conclusion, I look forward to working with the Board to forge a more collegial atmosphere of cooperation that will benefit the students and allow more administrative time to deal with instructional program issues."

- Mr. Mulvihill expressed that they used to be in large volume and had tremendous amount of detail. The Minutes can be made as detailed or as brief.
- Ms. Seymore agreed that, "In essence, Ms. Famularo is correct, but every word that is said at these meetings doesn't have to be put in here."
- Ms. Famularo expressed that it can be "listed with bullets...and that if we are going to go by tapes and video, then, every board member should receive a tape or video."
- Dr. Bailey and Mrs. Graves informed everyone that on our Pleasantville School District's Website, a link can be provided to allow the public to access the Board Meeting videos.

12. Public Comments: Jean Allen of 109 W. Park Avenue, Pleasantville, NJ - Being a graduate and former teacher of Pleasantville High School, commented that when her daughter was fifteen years old, she removed her from the Pleasantville School District and home-school her. BE IT RESOLVED BY THE PLEASANTVILLE BOARD OF EDUCATION OF THE CITY OF PLEASANTVILLE IN THE COUNTY OF ATLANTIC, NEW JERSEY PROVIDING FOR THE ACQUISITION AND INSTALLATION OF LAPTOP COMPUTERS, DESKTOP COMPUTERS AND WHITE BOARDS AND THROUGH A LEASE PURCHASE TRANSACTION AND AUTHORIZING EXECUTION OF A LEASE PURCHASE AGREEMENT AND OTHER RELATED AGREEMENTS AND ACTIONS NECESSARY TO ACCOMPLISH THE TRANSACTION

WHEREAS, The Board of Education of the City of Pleasantville in the County of Atlantic, New Jersey (the "Board") has determined to finance the acquisition and installation of laptop computers, desktop computers and interactive white boards (the "Equipment") through a lease purchase transaction; and

WHEREAS, the Board has selected Phoenix Advisors, LLC, to serve as financial advisor (the "Financial Advisor") and McManimon & Scotland, L.L.C., to serve as Special Counsel (the "Special Counsel") for the transaction contemplated herein (collectively, the "Professionals"); and

WHEREAS, the Board has followed the procedures required by N.J.S.A. 18A:20-4.2(f) and N.J.S.A. 18A:18A-1 et seq., and the regulations promulgated thereunder; and

WHEREAS, the Board has authorized the solicitation of bids for the financing of the Equipment pursuant to a lease purchase agreement for a principal amount not to exceed \$3,100,000 and hereby ratifies the publication of the notice of request for the receipt of bids; and

WHEREAS, the notice of request for bids (the "Request for Bids"), which established the criteria for awarding the bid to the lowest responsive and responsible bidder and established the index for the interest rate for the financing, was published on May 5, 2011, and bids were received on May 19, 2011 in accordance with the Request for Bids; and

WHEREAS, of the bids submitted, Bank of America Public Capital Corp. submitted the most responsive and responsible bid, and the Board wants to award the lease purchase financing to such company in accordance with its bid and the Request for Bids; and

WHEREAS, the Board now intends to enter into an equipment lease purchase agreement with Bank of America Public Capital (the "Lease") to be dated on or about June 16, 2011 or such other date as agreed to by the Business Administrator/Board Secretary;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF CITY OF PLEASANTVILLE IN THE COUNTY OF ATLANTIC, NEW JERSEY AS FOLLOWS:

Section 1. The Board hereby approves the bid submitted by Bank of America Public Capital Corp. (referred to hereinafter as the "Purchaser" or sometimes the "Lessor") to enter into the Lease at an annual interest rate of 1.94% for a term of not to exceed three years in the principal amount of not to exceed \$3,100,000, representing the principal portion of the rent payments under the Lease. This award is being made in accordance with the Request for Bids and the bid submitted by the Purchaser to the Business Administrator/Board Secretary, on or about May 19, 2011, and on file with his office. The Purchaser's interest rate will be held fixed for a period of 30 days from the date of the bid. If the closing does not occur within 30 days of the date of the bid, the interest rate will be calculated in accordance with the index rate set forth in the Request for Bid.

Section 2. The Board hereby authorizes the execution and the delivery of and the performance by the Board of its obligations under the Lease and other related financing agreements and documents, which shall be in the form approved by Special Counsel. The Board hereby authorizes and directs the Board President and/or the Business Administrator/Board Secretary to execute such documents on behalf of the Board, and the signature of such official shall be conclusive proof of such approval.

Section 3. The payments of rent or other monies due under the Lease shall be made only from the General Fund of the Board. Neither the Board nor any agency, department or political subdivision thereof shall be obligated to pay any sum to the Lessor under the Lease from any taxing source for the payment of any sums due under the Lease. The obligations of the Board under the Lease shall not constitute indebtedness of the Board or of the constituent municipalities or of any department, agency or political subdivision thereof. The Lease sets forth the term of the lease purchase acquisition by the Board for the acquisition of the Equipment, the rental payments to be paid by the Board in respect thereof and the dates on which rents shall be due and payable.

Section 4. The proceeds of the sale of the Lease shall be applied to (i) pay costs to acquire and to install the Equipment, and (ii) pay the costs of entering into the Lease.

Section 5. The Business Administrator/Board Secretary is authorized to direct the investment of funds under an escrow deposit agreement (the "Escrow Agreement") between the Board and Deutsche Bank National Trust Co., as escrow agent, consistent with the provisions of New Jersey law and the Escrow Agreement and is authorized to enter into such agreements, to execute such documents on behalf of the Board as may be necessary therefor and to pay any associated costs with the Escrow Deposit Agreement.

Section 6. The Board hereby covenants that it will comply with any conditions subsequent imposed by the Internal Revenue Code of 1986, as amended (the "Code"), in order to preserve the exemption from taxation of the interest portion of the rental payments under the Lease, including, if applicable, the requirement to rebate all net investment earnings on the gross proceeds above the yield on the Lease. The Board hereby declares its intent to issue the lease in the expected maximum principal amount of the Lease set forth herein and to use the proceeds of the Lease to pay or reimburse expenditures for the costs of the purpose for which the Lease is authorized herein. This resolution is a declaration of intent within the meaning and for the purposes of Treasury Regulations Section 1.150-2 or any successor provisions of federal income tax law.

Section 7. The Business Administrator/Board Secretary and/or the Board President and other appropriate representatives of the Board are authorized to take any and all actions necessary to implement the transaction and the agreements authorized herein, and any such actions taken prior to adoption of this resolution, including the publication of the notice of the Request for Bids, is hereby ratified and approved.
