- 5. Resolution to approve Underwater Robotics Program for Middle School 8th grade and the G&T students. Middle School science and G&T teachers will identify students to participate in the Underwater Robotics program in conjunction with Atlantic City Schools and Ocean Side Charter School sponsored by Dr. Bunting of American Engineers in partnership with Pleasantville Schools. The Under Water Robotics materials and training is free. Transportation to Gardner's Basin at least four times will be needed at a cost of \$1,000.00 (\$250.00 per trip) and one trip to Philadelphia for competition at a cost of \$450.00. There will be weekly meetings for families to learn life skills such as effective communication, domestic violence, sexual abuse, addiction, homelessness as well as HIV/AIDS. The program will be held at the Middle School of Pleasantville on Mondays from 5:00pm 7:00pm beginning October 17, 2011 through January, 9, 2012. The Project Rebuild Family-to-Family program is at no cost to the district.
