Dear Pleasantville Board of Education Members.

Per N.J.S.A. 18A:7A-55(a), "the Commissioner of Education shall have the authority to appoint a State monitor and additional staff, as necessary, to provide direct oversight of a board of education's business operations and personnel matters...".

This correspondence relates to oversight of the Board's business operations, specifically actions taken during the Board of Education's January 6, 2016, reorganization meeting.

The electronically recorded proceedings from the reorganization meeting were made available on January 26, and upon review of that record, the resolutions pertaining to RFPs and appointment of legal counsel have been taken under advisement.

First, review of the recorded proceedings reflects that following the election of officers and prior to the executive session, the Board discussed a motion regarding issuing a request for proposals (RFP) for legal services. Following the discussion, which included reference to the motion specifically pertaining to Smith Legal and Carroll Law, the Board approved the motion to procure legal services RFPs. This action is consistent with 6A:23A-5.2(a5), which states:

Professional services contracts are issued in a deliberative and efficient manner such as through a request for proposal based on cost and other specified factors or other comparable process that ensure the district receives the highest quality series at a fair and competitive price or through a shared serves arrangement. This may include, but is not limited to, issuance of such contracts through a requisition for proposals (RFP) based on cost and other specified factors or other comparable process...

Later, the Board adjourned to executive session and when reconvened took additional action. Specifically, James Carroll read aloud a resolution to extend the current professional services contracts of both The Smith Legal Group and The Carroll Law Firm. The Board subsequently made the necessary motions and passed that resolution.

Upon review of the reorganization meeting proceedings, it does not appear that the Board rescinded its earlier action to go out for RFPs before subsequently taking action on the consent agenda item introduced after the executive session.

Having taken the resolutions under advisement, the post-executive walk on resolution that extended the appointment The Smith Legal Group, LLC and the Carroll Law Firm is overturned. The Board's initial resolution to solicit RFPs for legal services is affirmed.

Finally, this determination neither precludes either The Smith Legal Group, LLC or the Carroll Law Firm from responding to RFPs nor diminishes the opportunity for either firm henceforward. Sincerely,
