8. A RESOLUTION AUTHORIZING THE ENTRY INTO AND EXECUTION OF A SHARED SERVICES AGREEMENT WITH THE CITY OF PLEASANTVILLE FOR THE PROVISION OF SECURITY SERVICES FOR THE PLEASANTVILLE SCHOOL DISTRICT"

WHEREAS, the Pleasantville Board of Education ("PBOE") advised the City of Pleasantville that the PBOE is in need of security services on school properties within the Pleasantville School District ("District"); and

WHEREAS, the City of Pleasantville can assist the PBOE with security services by assigning Pleasantville Class III officers to perform security services within the District; and

WHEREAS, the PBOE and the City desire to formalize a relationship through a shared services agreement for such security services; and

WHEREAS, N.J.S.A. 40A:65-1 et. seq., the Uniform Shared Services and Consolidation Act authorizes the municipalities to enter into shared services agreements to accomplish any function which either unit could perform on its own in an effort to reduce local expenses funded by property taxpayers and ratepayers; and

WHEREAS, the City and PBOE (the "Parties") have negotiated the terms and conditions for the preparation of a Shared Services Agreement pursuant to which the City will provide the services of Class III Officers to be assigned to perform security services for the Pleasantville Board of Education, the form of which is attached hereto;

NOW, THEREFORE, BE IT RESOLVED by the Pleasantville Board of Education is hereby authorized to enter into and execute a Shared Services Agreement with the City of Pleasantville pursuant to which the city will provide the services of Class III Officers to be assigned to perform security services for the Pleasantville Board of Education, in the form substantially as attached hereto and made a part hereof.
