Reconvene Board Meeting-Action after Executive Session

Board Attorney Jim Carroll stated that the board would have to revote for the Interim Superintendent, Assistant Superintendent, and Business Administrator Contracts due to the fact that a motion to use the Doctrine of Necessity had to be evoked before the recused board members could cast their vote.

RESOLUTION ON INVOKING THE DOCTRINE OF NECESSITY

WHEREAS, the School Ethics Act (N.J.S.A. 18A:12-21 et seq.) was enacted by the New Jersey State Legislature to ensure and preserve public confidence in school board members and school administrators and to provide specific ethical standards to guide their conduct; and

WHEREAS, the School Ethics Commission has provided guidance in Public Advisory Opinion A03-98, as to when and how the Doctrine would be invoked; and

WHEREAS, the Doctrine of Necessity, allow Board Members who are otherwise prevented from voting due to a conflict of to cast a vote; and

WHEREAS, due to the absence of one of the Board Members and the recent vacancy on the Board, only seven (7) members were present at tonight's meeting; and

WHEREAS, three of the remaining Board Members recused themselves from voting due to the fact that they have relatives working as employees in the District; and

WHEREAS, it was necessary to vote on the renewal of the contract for the Interim Superintendent, the Business Administrator and the Assistant Superintendent since this is the last regular Board Meeting before the expiration of their current contract; and

WHEREAS, in order to approve the contracts a majority of the full Board is required to approve the contracts, i.e., five votes are required five votes are required, it is therefore necessary for one of the conflicted Board Members to cast an affirmative vote in order for the Contracts to be approved; and

WHEREAS, the Board Members that were conflicted by have stated on the record the specific reason for their recusal from the vote; and

NOW THEREFORE BE IT RESOLVED that the Doctrine of Necessity be invoked; and

BE IT FURTHER RESOLVED that a copy of the resolution be posted where it posts public notices for 30 days and a copy of the resolution be provided the School Ethics Commission.
