**WHEREAS**, The Board of Education has elected to exclude travel expenditures supported by federal funds from the maximum travel expenditure amount; and

**WHEREAS**, The Board of Education has determined that the total amount of travel expenditures supported by federal funds from the 2016/2017 school year is \$5,000.00, and

**RESOLVED**, That the Pleasantville Board of Education hereby establishes the maximum travel expenditure amount for the 2017/2018 school year as \$25,000.00, and
